You'll be given 2.5 hours to complete the exam and will need a score of 49 or higher to pass.

- CEU hours: For those holding either a real estate broker or a property management license, this course fulfils I4 CEU hours for the two day lecture course and I6 CEU hours for the two day course and the pre-exam review on the third day.
